Comparison and Analysis of Special Pupil Attainment

Specification for Comma Separated Variable data files for import or refresh of pupil data in the LA Module of CASPA

This specification details the items of data required for preparation of Comma Separated Variable files containing pupil data from which pupil records in the LA Module of CASPA are to be either created or refreshed. The format and valid values for the items of data required are based on the Common Basic Data Set (CBDS) specification issued by the DCSF on 27th May 2011. Details of the CBDS can be found at:

Creation and refresh of pupil records in the LA Module of CASPA is intended only for pupils whose data is not held in a school module of CASPA and whose CASPA results cannot therefore be exported from a school module of CASPA for import into the LA Module of CASPA.

Where the comma character is used in an item of data, the relevant data item must be enclosed in double quotes in the CSV file.
